**(A Private Cannabis Collective)**

## **1. Name**

The name of the collective is The Marijuana Club (Pty) Ltd, hereinafter referred to as "the Club."

## **2. Legal Status**

The Club is a registered Private Company (Pty) Ltd operating on a nonprofit model. It functions exclusively as a private cannabis collective for consenting adult members, in compliance with South African laws permitting private use and cultivation of cannabis.

## **3. Nature of Activities**

**The Club:**

Operates as a closed-loop private cannabis collective, accessible only to registered members. Facilitates private, non-commercial access to cannabis through a donation-based, nonprofit model.

Maintains cannabis supplies sourced exclusively from:

Approved Grower Members (Club Growers) who cultivate cannabis exclusively for the Club. Supplier Members who supply cannabis or cannabis products to the Club but are not bound by exclusivity. Provides education, guidance, and support to Member Patients and Grower Members. Upholds privacy, dignity, and compliance with South African law at all times.

## **4. Objectives**

1. To facilitate private, legal access to cannabis for Grower Members, Supplier Members, and Member Patients.
2. To support exclusive cultivation by Grower Members for the Club.
3. To allow Supplier Members to supply cannabis or products without exclusivity, provided they are registered members.
4. To promote responsible use, education, and safe cultivation practices.
5. To operate on a cost-recovery donation model, without profit motive.

## **5. Membership**

### **5.1 Categories of Membership**

#### **Grower Members (Club Growers):**

**Adult members exclusively approved to cultivate cannabis only for the Club. Grower Members commit not to supply cannabis to any other entity or for commercial purposes.**

#### **Supplier Members:**

**Registered members who supply cannabis or cannabis products to the Club but are not exclusive growers. Supplier Members may grow or source cannabis for multiple purposes but must comply with Club policies when supplying cannabis to the Club.**

#### **Member Patients:**

**Adult members who access cannabis for therapeutic or medical use through the Club's donation-based system.**

### **5.2 Eligibility**

**Must be 18 years or older and resident in South Africa.**

**All members must sign the Membership Agreement and adhere to this Constitution.**

**Grower Members must be screened and approved for exclusivity.**

**Supplier Members must be registered members in good standing.**

### **5.3 Rights of Members**

**All members have the right to:**

**Access Club cannabis and services under the donation system.**

**Participate in Club initiatives and request support.**

**Expect privacy, dignity, and respect within the Club.**

### **5.4 Responsibilities**

**All members must:**

**Use and share cannabis only within the Club's private domain.**

**Abide by Club policies and South African laws.**

**Respect the privacy and dignity of all members.**

**Grower Members must:**

**Cultivate cannabis exclusively for the Club.**

**Not supply cannabis to other clubs, dispensaries, or the public.**

**Supplier Members must:**

**Be registered members in good standing.**

**Supply cannabis in compliance with Club rules.**

**May grow or source cannabis beyond the Club but must only supply to the Club as members.**

## **6. Cannabis Sources**

**Cannabis distributed within the Club is sourced solely from:**

### **A-Grower Members (Exclusive Club Growers)**

**Growers who cultivate cannabis exclusively for the Club under Club approval and reporting.**

### **B-Supplier Members**

**Registered members who supply cannabis or cannabis products to the Club.**

**Suppliers may or may not grow cannabis exclusively for the Club.**

**All suppliers are vetted and must adhere to Club policies regarding quality, documentation, and non-commercial distribution.**

## **7. Governance**

**The Club is managed by a Director, supported by a Club Committee if appointed.**

**The Director oversees compliance, cultivation operations, and supplier relations.**

**Decisions and amendments are made in accordance with this Constitution.**

## **8. Donations and Finances**

**The Club operates solely on a voluntary donation basis.**

**No cannabis is sold commercially.**

**Donations cover cultivation, packaging, distribution, and operational costs.**

**Financial records are maintained transparently and are accessible to members upon request.**

## **9. Support for Member Patients**

**Peer-led guidance on cannabis use, strain selection, and dosing.**

**Access to Club cannabis via the donation system.**

**No medical advice or prescriptions are provided by the Club.**

## **10. Confidentiality and Privacy**

**All member information is confidential and protected.**

**Medical or therapeutic information provided by Member Patients is stored securely and accessed only by authorized staff.**

**The Club complies fully with the Protection of Personal Information Act (POPIA).**

## **11. Record-Keeping**

**The Club maintains records of:**

**Member agreements and consent forms**

**Cultivation logs and yield reports from Grower Members**

**Donation and supply records**

**Records are securely stored and accessed only by authorized personnel.**

## **12. Code of Conduct**

**All members agree to:**

**Act with respect, discretion, and professionalism.**

**Avoid behavior that jeopardizes the Club's legal standing or reputation.**

**Refrain from harassment, discrimination, or intimidation.**

**Grower Members must uphold their cultivation exclusivity.**

**Supplier Members must adhere to Club rules and confidentiality.**

## **13. Disciplinary Procedure**

**The Club may take disciplinary action if a member:**

**Violates this Constitution or any Club policies.**

**Cultivates, uses, or distributes cannabis outside the Club's rules.**

**Endangers the Club's legal compliance or reputation.**

**Possible actions include:**

**Written warnings**

**Suspension of membership**

**Termination of membership**

**Members have the right to appeal decisions in writing within 14 days of notice.**

## **14. Definitions**

**Closed-loop: A private system where cultivation and distribution occur only between registered members.**

**Donation-based: Members voluntarily contribute to cover Club costs; cannabis is never sold.**

**Private domain: Legal framework allowing adults to use, grow, and share cannabis privately within the Club.**

**Grower Members: Members with exclusive rights to cultivate cannabis solely for the Club.**

**Supplier Members: Members who supply cannabis or products to the Club but without exclusivity requirements.**

**Member Patients: Members who use cannabis for therapeutic or medical reasons.**

## **15. Amendments**

**This Constitution may be amended by the Director or Club Committee with 14 days' notice.**

**Members will be informed of any significant changes.**

## **16. Dissolution**

**If the Club dissolves:**

**All cannabis stocks will be safely and lawfully destroyed.**

**Assets will be donated to an appropriate nonprofit cause.**

**Member data will be deleted in accordance with POPIA.**
